To the fullest extent permissible by law, I hereby release, waive, discharge and covenant not to sue the Club or any Landowners for any liability, and further agree to indemnify and hold them harmless for accident or injury whether caused by the negligence of the Club or the Lanowners, or otherwise.

It is State Law and your responsibility to wear a helmet, have your machine registered and insured, and be able to prove it. Federal, State and Local Codes, Regulations and Laws must be obeyed at all times.

"CLUB RULES AND CODE OF ETHICS"

- 1) *Current club stickers are to be placed on the front left side of all machines.*
- 2) *I will slow down, use caution and be courteous when I encounter other trail users. Our trails are designed for riding on, not racing on.*
- 3) *I will ride only on designated trails and areas and will not bypass our bridges and stream crossings by going up and down streams.*
- 4) *I will respect and preserve the public and private property that I ride on. I will not go around wet holes and make them bigger as it causes more work and expense. If you do not want your machine to get muddy then it is best to keep it in the garage.*
- 5) *I will make sure my equipment meets NYS safety, insurance, registration and noise limitations.*
- 6) *I will not endanger myself and other trail users by riding beyond my ability or while impaired by drugs or alcohol. It is my duty as a club member to report any other rider that is not obeying the club rules and state laws.*
- 7) *I will not construct jumps or obstacles anywhere on the trails or riding areas. It is my duty to help keep our trails clean and safe. If you see debris on our trail, such as cans, bottles, cigarette packs, etc., pick them up. Report any unsafe conditions to the Board or line officers, such as beaver dams, flooding, wash outs, fallen trees, etc.*
- 8) *Club membership may be terminated at any time after a meeting with the complaint committee. Just cause for termination includes, but is not limited to, failure to abide by our club rules and code of ethics.*
- 9) *I will try to make work details or work at fund raisers.*
- 10) *I will obey the club speed limits: 15 mph in the Village of Altmar; 25 mph on all other black top town roads that have been opened to us.*
