Meeting was held July 17th at the club house pavilion, approximately 30 people were in attendance. There were discussions concerning trail closures, Sheriff Patrol, trail work, upcoming events, new sponsors, etc.

The Falls Rd Trail is CLOSED! This is a permanent closure. We ask that you no longer use this section of trail to get to the Salmon River Falls. The new owner has made it clear he will be blocking it off and will charge people with trespassing if caught. You are still able to use Falls Rd itself to get to the falls or Damn Rd to get to Redfield. There is no working with the owner to reopen this trail.

August 21st meeting will be held at the Brian Parker Training Center, Hogs Back Rd. This is also our family fun day. Meeting starts at 11am, fun begins after. Come on out!

Landowner/Worker Dinner, August 14th, 2-5pm, club house pavilion, chicken or steak dinners. This is a time change from previous years to allow time for anyone who wanted to attend the parade and celebration for Jr. O'Neil.

Memberships:

Single: \$35, 1 machine only

Family: \$45, up to 3 machines only, \$10 for each additional machine, maximum of 5 machines for family membership

Each application **WILL** require, machine year, brand, model, color, UTV dry weight total, plate number (if legally registerable in NYS). ANY application **NOT** containing all information, will not be processed.

All machines allowed on the trail system **MUST** have the yearly membership sticker placed on the front left of the machine, so it is visible.

Riding on a membership receipt will no longer be allowed.

Replacement stickers will be **\$10**.

1-day passes are **ONLY** for the month of September, **\$15**.

Memberships are mailed after payment methods have been cleared, whether it's a check, money order, PayPal, etc. All applications are reviewed for completeness, accuracy of information for machines, that rules are signed in agreement, addresses, phone numbers, etc. If something is not complete, this delays

the mailing of your membership card and stickers. This applies to online memberships as well, these are also printed and reviewed.

Please allow 7-14 days to receive your membership. Becky is the only membership chairperson; she works a fulltime job doing 12hr shifts. She is a volunteer, like everyone in this club. There is NO MORE riding on receipts. you MUST receive your membership, and have your sticker placed onto your machine PRIOR to riding the trail system. You MUST plan ahead, if joining online during a week, you most likely WILL NOT receive your membership in the mail by that same wknd. Plan Accordingly!! Becky is very accommodating, and arrangements can be made to either receive your membership by pickup at the club using the club's new pickup box, or make an in per person appt. But YOU MUST make contact prior. The best, easiest, and quickest contact method is sending an Instant Message via the clubs facebook page. "Oswego County ATV Club, Inc". Messages are instantly alerted to Becky, and her husband Brad (VP) for quick answering. You can also send a text message to (315)480-5104. Or call (315) 298-6081.

Falls Rd Trail is permanently closed!

Trail Work:

Trail workers are out on the trails, fixing holes, putting up signs, trimming, etc., making sure the trails are safe. If there is an issue on one of the trails, let someone know so it can be handled.

Please contact a trail boss if you can come out and help. We need more people to help with trail work. Most of this work is done by older members.

The club is looking into getting some "Trail Maintenance Ahead" signs, this should hopefully help cut down on the speeding through areas that are being worked on

Trail Patrol/Sheriff Patrol:

Our regular trail patrol has been out on the trails under the direction of Brad, making sure machines have stickers, members are wearing helmets, following the rules, etc.

The Sheriff Patrol has been out as well, and it has made a difference already with the patrolling of our trail system. There have been some tickets written and a couple members removed from the club. The club is no longer going to tolerate breaking the rules, riding unsafe, destroying property and disrespect, either to landowners, other club members, board members, residence, businesses, other members of the public, pedestrians, and the like.

Training Course:

Wayne Slate is once again doing the training courses for this year. All classes so far have been full. He will hold more throughout the season as interest increases.
